The land is accessed from Star Fen and is located approximately 3.8 kilometres (2.4 miles) north-east of the village of Heckington.

DESCRIPTION

SOIL TYPE

The land is classified by the former MAFF Land Classification Maps of England being mainly Grade II agricultural land with a small area of Grade III to the southern end. It is described as mainly loamy and clayey soils of coastal flats with naturally high groundwater with slowly permeable and seasonally wet slightly acid but base-rich loamy and clayey soils to the southern section.

BASIC FARM PAYMENT ENTITLEMENTS
